PRODUCT DESCRIPTION

H&C® DURA-TOP™ Concrete Resurfacer Liquid Release is developed for use when stamping freshly placed colored or uncolored concrete or imprintable cementitious toppings. It promotes easy release of stamping and texturing tools and improves results by preventing transfer of the wet paste when the tools are removed from surfaces. The release agent forms a bond breaking barrier that helps prevent the tools from sticking and marring the pattern in the fragile surface of the fresh concrete of cementitious topping. The pleasant, bubblegum type scent helps to identify the product.

JOBSITE TEST SECTION

Due to the wide variety of substrates, preparation methods, application methods and environments, it is important to create a test sample.

TOOLS REQUIRED

- 1/2" (13mm) drill
- Drill must be a slow or variable speed drill
- Mixing paddle
- Respiratory Protection
- Eve Protection
- Gloves
- Pump-Up Sprayer
- Imprinting Tools
- H&C CONCRETERADY Ethcing Solution

APPLICATION INSTRUCTIONS

Apply an even coating of H&C DURA-TOP Liquid Release on your imprinting tool along with the area to be stamped.

Prior to application of any concrete stain, sealer or concrete coating, a wash coat of H&C CONCRETEREADY Etching Solution (5:1 water to Etcher) should be applied to the stamped surface. The wash coat will remove any release agent that may have formed a seal on the surface, which can prevent penetration and adhesion of a stain, sealer or coating. Agitating the Etching solution with medium/soft bristle brushes will help to remove any residual release agent. Thoroughly rinse the surface with clean water to remove all residual etching solution. Once dry, test the overlay for porosity by dropping water onto the surface. The water should penetrate quickly and slightly darken the overlay. Any water beading or standing on the surface means residual release agent is still present and another wash coat of the H&C CONCRETEREADY Etching Solution should be performed and water test done.

CLEANUP

Clean tools and any spills or spatters immediately using soap and warm water. Clean hands immediately after use with a waterless hand cleaner.

MAINTENANCE

Clean surfaces coated with H&C DURA-TOP Concrete Resurfacer Liquid Release using a mixture of 3 parts water to 1 part H&C CONCRETEREADY Cleaner Degreaser.
