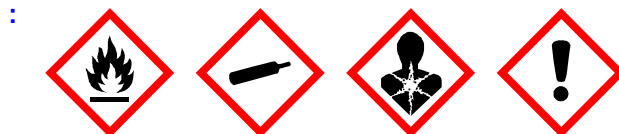

Description of necessary first aid measures

Personal precautions, protective equipment and emergency procedures

Section 7. Handling and storage

Protective measures
