	Note: Tough Coat Quik-Dry must be catalyzed at an 8:1 ratio (1 pint per gallon) with Alkyd Hardener prior to reduction. With the induction of Alkyd Hardener, dry times will be slower than Tough Coat Quik-Dry uncatalyzed and are as follows:
To Touch:	15 - 20 minutes
To Handle:	40 - 60 minutes
To Tape:	60 - 90 minutes
To Recoat	After 60 minutes
To Pack	24 hours
Pot Life	6 - 8 Hours

Alkyd Hardener must be protected from contamination, especially with moisture. Moisture will react with the catalyst, thereby decreasing its effectiveness, which may lead to incomplete curing of the paint film.
