SECTION 4: First aid measures

Protection of first-aiders

No action shall be taken involving any personal risk or without suitable training. SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

8.2 Exposure controls

Appropriate engineering controls
