Fade-A-Way Dye Additive is a translucent colorant which is added to Diamond-Clad Clear Coat to ensure a uniform application of the clear coat.

The addition of Fade-A-Way to Diamond-Clad Clear Coat provides a temporary color contrast to the existing base coat during application. The colorant generally dissipates within 72 hours. Low temperatures and indirect sunlight will slow the rate of disappearance.

Packaging:	2 mL plastic vial, sealed in mylar. Fade-A-Way is UV sensitive and must remain in the mylar package until use.
Mixing:	Add one 2 mL vial per each .81 gal (3.1L) kit of Diamond-Clad Clear Coat. Add Fade-A-Way to Part A, while Part A is under low speed power agitation. Continue agitation while adding the Part C and then Part B. Mix thoroughly with low speed power agitation. An additional vial of Fade-A-Way may be used to increase the color intensity, however, the time required for dissipation of the color will be extended.
