4.2 Most important symptoms and effects, both acute and delayed

Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness. Solvents may cause some of the above effects by absorption through the skin.

If splashed in the eyes, the liquid may cause irritation and reversible damage.

Repeated or prolonged contact with the mixture may cause removal of natural fat from the skin, resulting in non-allergic contact dermatitis and absorption through the skin. 6.1 Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

6.2 Environmental precautions

Information on fire and explosion protection

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air.
