## Section 2. Hazards identification

### **Prevention**

### **Description of necessary first aid measures**

### **Eye contact**

### Skin contact

# Specific hazards arising from the chemical

For non-emergency personnel

## Section 6. Accidental release measures

### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13).
