GENERAL DESCRIPTION

NOTE TO USER

To ensure desired appearance and proper drying time, always finish a small test area before proceeding.

TINTING

White and Neutral Bases must be tinted with compatible colorants.

MILDEW

Any mildew stains present on the surface prior to application should be removed with an exterior wood cleaner. Mildew stains are not caused by the coating, nor do they represent coating failure. This product contains agents that inhibit the growth of mildew on the coating's film.

EXTRACTIVE BLEEDING

Extractive bleeding is not caused by the coating, nor is it a coating failure.

SURFACE PREPARATION

In order to be effective, a stain must be able to penetrate. Be sure surface is free of all dirt, mildew stains, loose wood fibers, peeling coatings and other foreign matter. Surfaces must be sound and may be dry or damp. If damp, the wood should be free of puddles and not feel wet. Prepare previously stained or weathered surfaces by cleaning with an exterior wood cleaner. On untreated weathered surfaces, it is best to pressure wash, but at minimum, scrubbing with a stiff bristle brush and wood brightener, then rinsing with a garden hose should be done to completely remove all loose or gray wood fibers. If removing additional loose wood fibers is necessary, sanding with 60 or 80 grit paper may be required.

RESTRICTIONS

Do not apply in direct sunlight, to hot surfaces or when air or surface

temperature is below 35 °F (1.6 °C) or may fall below 35 °F (1.6 °C) for 24 hours after application. Can be applied to both damp and dry wood. Do not stain if rain is expected within 4 hours after staining. Do not intermix with any other products. Do not thin. Protect containers from freezing.

FOR EXTERIOR USE ONLY.

APPLICATION

Apply with nylon or polyester brushes, high-quality roller, stain pads or professional spray equipment. When rolling or spraying, always back-brush immediately. Initially apply the stain against the grain, being careful not to leave any area uncoated. Then brush with the grain to smooth the coating. Leave a good coat of stain, do not brush the stain out too thinly. Stain maybe applied to damp, but not wet wood. To ensure desired appearance and proper drying time, always finish a small test area before proceeding. Do not overapply. Shake and stir thoroughly before and during use. If project requires more than 1 blend all containers container, together to ensure uniformity. Apply to small sections at a time (1-3 boards); start at one edge of the board and work end-to-end, following through to the end of the boards to avoid lap marks.

DRY TIME

Dries in 4 hours for light foot traffic in normal conditions. For best results apply above 50 °F. Allow 24 hours for full cure and return to full service. Rain and moisture resistant after 4 hours. Although one coat coverage is recommended, if a second coat is desired, allow 2-4 hours drying time before recoating.

CLEANUP AND DISPOSAL

Clean up with warm, soapy water. Do not freeze. Keep container closed when not in use. Do not transfer contents to other containers for storage or disposal. In case of spills, absorb with inert material such as sand or kitty litter. Dispose of empty container or unused portion in accordance with local, state and federal regulations.
